#### Agenda No. 18/01: Approval of the 17th IQAC Meeting Minutes

#### Agenda No. 18/04 Proposed dates for the Academic Audit for the Academic Year 2024–25.

The dates for the final Audit for the Academic Year 2024–25 was proposed in the second week of August 2025.



After due consideration and deliberation, the last week of August 24-31, was finalized for conduction of the Audit of Academic and functional units. The audit calendar shall be shared with all the stakeholders.

Schools and other unit heads were requested to begin preparations accordingly and ensure all relevant documentation and records are in order.

#### Agenda No. 18/05 Data collection formats for Academic and Functional Units.

It was briefed to all the members to avoid redundancy in data collection and optimize the time and efforts in the process and to support the transition toward a fully digitized system, Excel-based comprehensive data capturing formats are being introduced as an interim solution. The formats have already been shared with a few key units, while the remaining are currently in progress and will be provided shortly. This initiative aims to streamline data collection processes across schools and units and ensure consistency and readiness for digital integration. All concerned units were requested to begin data entry upon receipt and extend full cooperation for timely submission.

## Agenda No. 18/06 Inclusion of SDG keywords in BMU faculty publications to strengthen sustainable research impact.

It was discussed and agreed that the inclusion of Sustainable Development Goal (SDG) keywords in BMU faculty publications is essential to enhance the visibility and impact of sustainable research. The details of the communication share don 11 June 2025 with all stakeholders were briefed.

It was decided that an official communication regarding this will be circulated from the Vice Chancellor's Office. The Director – Research & Development will be the designated process owner to oversee the implementation and ensure compliance across all academic units.

The details of the recent THE Impact rankings were shared with all members. The University has been placed in the 801–1000 band globally in the Overall Ranking and other SDG rankings.
