Revised Fee Refund Policy for Batch-2026
(For All Programmes offered by BML Munjal University)

The Fee Refund Policy is applicable to all the students admitted in the Academic Year 2026-27. It is hereby informed that the Fee Refund Policy issued by the University Grants Commission (UGC) for the Academic Year 2024-25 is currently in force and shall remain applicable for subsequent academic sessions, including 2026-27, until a new policy is issued by the UGC (D.O. No. F.12-5/2024 (FNT/NET) – Fee Nivaran, Notice dated October 27, 2025).

1. A full fee refund shall be made on account of all cancellations of student admissions/migrations up to September 30, 2026.
2. After the aforesaid date, a refund with a deduction of Rs. 1000/- as processing fee shall be made up to October 31, 2026.
3. For any admission schedule extending/commencing beyond/after October 31, 2026, the provision listed in the UGC Notification issued in October 2018 on Refund of Fees and Non-Retention of Original Certificates shall be applicable (appended below for ready reference):

| S. No. | Percentage of Refund of Aggregate Fees* | Points of time when notice of withdrawal of admission is received in the University |
|--------|---|---|
| 1 | 100% | 15 days or more before the formally notified last date of admission |
| 2 | 90% | Less than 15 days before the formally notified last date of admission |
| 3 | 80% | 15 days or less after the formally notified last date of admission |
| 4 | 50% | 30 days or less, but more than 15 days, after formally notified last date of formal notification of admission |
| 5 | 0% | More than 30 days after the formally notified last date of admission |

**(Inclusive of tuition fees but exclusive of security deposit)*

Note:

- Aggregate fees mean semester fees payable towards Tuition Fees.
- Days shall be counted from the date of receipt of the online/written request for withdrawal.

Hostel Fee Refund:

- Students who have applied for a refund before registration shall be applicable for a full fee refund.
- Students applying for a refund after registration shall be applicable for a refund on a pro-rata basis, subject to a seat being filled by a waitlisted student. However, if the seat remains vacant, the student shall be applicable for a refund only for the mess charges on a pro-rata basis.

Transportation Fee Refund:

- Students applying for a refund before registration shall be applicable for a full fee refund.
- No refund shall be made for the transportation fee after registration.

Note:

The University reserves the right to amend the policy subsequent to UGC notification for the Academic Year 2026-27.
