Education at BMU is designed to help students imbibe the following three key values:

Intellectual curiosity to Inquire, personal capability to Inspire, and commitment to deliver positive social Impact.

Education at BMU will build the ability to ideate and innovate solutions that contribute to the community and improve standards of living for all.

## Objectives

The idea of changemakers as being one of the distinctive features of BMU has been gleaned from the founding documents and the subsequent envisioning exercises. This is instilled by developing in students - self-esteem, a sense of inquiry, and responsible leadership as the core graduate attributes.

**Self-Esteem:** A strong sense of self-esteem empowers students with the confidence to navigate uncertainty, challenge norms, and create innovative solutions. When individuals believe their voice matters, they are more likely to take initiative, advocate for their ideas, and persevere despite obstacles. This confidence and adaptability are essential, where success often hinges on the ability to influence stakeholders, embrace feedback, and iterate ideas.

**Spirit of Inquiry:** Journey thrives on curiosity, critical thinking, and the ability to see beyond conventional solutions. A strong spirit of inquiry, defined by critical and divergent thinking, enables students to analyze problems deeply, challenge assumptions, and explore unconventional solutions.

**Responsible Leadership and Ethical Entrepreneurship:** Entrepreneurship is not just about creating profitable ventures but also about fostering ethical and sustainable solutions that benefit society. Responsible leadership, rooted in sensitivity and empathy, ensures that entrepreneurs consider the broader impact of their actions on communities, the environment, and global challenges.

Nation-building is one of the core purposes of BMU. We envisage nurturing graduates who are not only academically proficient but have the skills, mindset, and values to address real-world problems and make a positive impact on society.



# STRATEGIC GOALS

## *Positioning BMU as a University known for nurturing Changemakers*

BMU has identified nurturing changemakers to lead with purpose as a central theme for 2025-2030. This includes innovation, problem-solving, ethical leadership, and entrepreneurial spirit. Importantly, we distinguish between fostering an entrepreneurial spirit and directly creating entrepreneurs—later is only a subset of the former.

To attain distinctiveness, BMU has resolved to work on the three core areas that would take it closer to distinguishing itself as a university committed to building and nurturing changemakers amongst its students and creating a social impact.

# ACTIVE LEARNING

## *Blending Experiential Learning with critical reflection and spirit of inquiry*

Active learning thrives in a vibrant, self-reflective ecosystem that extends beyond the university, engaging with industry and immersing in the community. Three essential components of active learning are: **Experiential Learning** - Bringing real-world scenarios into the curriculum; **Critical Reflection**- Encouraging students to analyze and evaluate their learning experiences rather than passively absorbing information; **Immersive Learning**- Engaging with both human and non-human environments to develop problem-solving skills and a deeper understanding of real-world complexities.

Moving away from traditional lecture-based teaching ensures that students become active participants in their own learning journeys. By integrating experiential learning with critical reflection, we can help students engage more deeply with knowledge, texts, and real-world situations. The classroom itself needs to be reimagined beyond the conventional four walls. Another critical aspect is rethinking how we assess students. We envision undergraduate students progressively taking on a more active role in their learning journey—from passive learners in their first year to becoming protagonists of their own learning by the fourth year. Faculty will increasingly become facilitators rather than just instructors.

- Transition from Experiential Learning (EL) to Active Learning (AL), integrating critical reflection and inquiry.
- Involve students as protagonists and teachers as facilitators, with experimental and interactive learning.
- Use of AI and emerging technologies for immersive learning experiences.
- Rethinking assessments: continuous and process-based evaluations over conventional exams.
- Expansion of flipped classrooms as an institutional practice.
- Implementation of interdisciplinary action research studios and practice schools.
- Focus on curriculum redesign, pedagogy transformation, and innovative evaluation methods.
- Redesigning physical learning spaces to encourage collaboration and hands-on learning.



# VIBRANT AND SELF-REFLECTIVE ECOSYSTEM

*Ecosystem to provide the tailwind for the change we aspire to bring*

A dynamic university ecosystem encourages students to voice their ideas, engage in diverse discussions, and take ownership of projects, reinforcing the belief that their contributions matter. When students participate in incubators, pitch competitions, or bargain for budgets for student activities, they gain real-world experience in validating their ideas, overcoming failures, and refining their approaches.

The focus for the next five years at BMU is to create and foster such a vibrant and self-reflective ecosystem through faculty and student excellence, participative governance, and institutional reforms. The university aims to create an innovation-driven campus by establishing interdisciplinary programmes, expanding student governance roles, and integrating entrepreneurship into academic and extracurricular activities. Infrastructure expansion and policy reforms will support these efforts, ensuring BMU nurtures a culture of reflection, leadership, and community engagement.

## **Hiring and Nurturing Quality Faculty by –**

- Maintaining a rigorous selection process
- Aligning their teaching skills through targeted training programmes, to promote Active Learning at BMU
- Enhancing onboarding, HR policies, and competitive compensation to attract top talent.

## **Selecting and Nurturing Quality Students by –**

- Increasing diversity and outreach efforts to underrepresented regions and international students.
- Positioning BMU as an aspirational institution through enhanced admission processes.

## **Strengthening a Self-Reflective Ecosystem by –**

- Institutionalizing Academic Council deliberations and encourage open discussions.
- Expanding cross-disciplinary foundational courses focusing on personal growth and self-reflection.
- Launching programmes to support and nurture career aspirations and personal development.

## **Enhancing BMU Citizenship and Participative Governance by-**

- Deepening student participation in university administration and decision-making
- Encouraging student involvement in research projects, teaching assistance, and governance roles.

## **Nurturing Entrepreneurial Spirit on Campus by-**

- Expand student-led ventures and alumni entrepreneur networks.
- Exposing all students and faculty to multiple entrepreneurial activities.
- Introduce degree and certificate programmes in entrepreneurship.
- Develop an Incubator Hub connecting founders, investors, research, and industry.

By actively participating in community-driven initiatives, and Translational Research, students cultivate self-esteem, a spirit of inquiry, and responsible leadership, enabling them to become change-makers who drive meaningful social and economic impact. Engaging and exchanging learnings and knowledge with communities outside the university is of critical significance in the conception of a contemporary university that wants to make a social impact.



### **Community Inspired Research and Outreach**

- Implement Makerspace, Studio Rashomon and Centre for Community Networks, Nurturing Reciprocal Engagement, Co-learning and Trust (CONNECT) across all schools to enhance hands-on learning and research.
- Flagship programmes having an integral component of social entrepreneurship in their curriculum.
- Establishment of Major Lecture Series in Each School.
- Setting up of Institute for Dialogue by Educators on Action and Research (I-DEAR).

### **Partnership through Entrepreneurship**

- Scale up the grassroots entrepreneurship programme for rural women in Haryana and Rajasthan.
- Develop local mentors to expand business training reach by institutionalizing Train-the-Trainer Programme for Entrepreneurship

### **Sustainability and Green Initiatives**

- Encourage students to work on real-world sustainability challenges
- Soliciting and securing CSR and Government Funding for Sustainability Initiatives
- Collaborate on sustainability, governance, and community development projects by fostering Partnerships with Government and Civil Society

### **Civic Engagement and Advocacy**

- Host discussions on pressing policy issues with stakeholders in Conferences and Workshops on Public Policy
- Creation of Centre for Public Policy and Advocacy and Governance
